Introduction

This Privacy Policy explains how we collect, use, store, and protect personal information of members and their families.

By creating an account or using our website, you agree to this Privacy Policy.

Information We Collect

A. Member Information

When you register, we may collect:

- Full name
- Email address
- Phone number
- Birth month and year
- Profile photo
- Mailing address (if applicable)

B. Family Member Information

If you provide details about your spouse and children (under 21), we may collect:

- Full name
- Birth month and year
- Photographs
- Relationship to member

By submitting this information, you confirm that:

- You are legally authorized to provide it
- You are the parent or legal guardian of any minor
- You consent to the collection and processing of their data

Children's Data

We collect limited personal information about children under 21 **only as provided by their parent or legal guardian** for community membership purposes.

We do not knowingly collect data directly from minors without parental consent.

Parents/guardians may request:

- Access to their child's information
- Correction of inaccurate data
- Removal of child's data
- Removal of photographs

Requests can be made using the contact details below.

Photographs & Event Gallery

As a community organization, we may:

- Take photographs during community events
- Publish event photos in the Website gallery
- Share event highlights with members

By participating in community events, you acknowledge that photographs may be taken.

If you do not wish for your or your child's image to be displayed, you may:

- Inform us in advance
- Request removal of specific images

We will respond to removal requests within a reasonable timeframe.

Payment Information

Payments are processed securely through PayPal.

We do not store full credit/debit card information. PayPal processes payment data in accordance with its own privacy policy.

We may receive limited transaction details such as:

- Transaction ID
- Payment confirmation
- Amount
- Date

How We Use Personal Information

We use collected information to:

- Manage membership accounts
- Communicate community updates
- Organize events
- Maintain membership records
- Process payments
- Publish event galleries
- Ensure Website security

We do not sell or rent personal information.

Data Sharing

We only share personal information when necessary:

- With service providers (e.g., PayPal for payment processing)
- When required by law
- To protect legal rights

We do not share data for advertising or marketing.

Data Retention

We retain personal information:

- While membership is active
- As required for administrative or legal purposes
- Until a deletion request is received (where legally permissible)

Event photographs may remain archived unless removal is requested.

Data Security

We implement reasonable administrative and technical safeguards to protect personal information, including:

- Secure servers
- Password-protected accounts
- Restricted access to member data

However, no online system is completely secure.

Your Rights

Depending on your jurisdiction, you may have the right to:

- Access your data
- Correct inaccurate information
- Request deletion
- Withdraw consent
- Request removal of photos

International Data Transfers

Your information may be stored or processed in countries outside your residence.
